## **Craft Vendors & Exhibitors**

This document contains pertinent rules and regulations that govern the operations of the Pocono Garlic Festival, hosted by Ski Shawnee, Inc. (SSI)

We are extending invitations to vendors who submit fully executed applications with required enclosures and payments (see application page) by the **July 1, 2010** deadline. Priorities for space will be reviewed based on past participation, date of receipt of fully executed application and type of product/item for sale.

Pocono Garlic Festival, LLC (PGF) strives to maintain balance, diversity and quality in vendor offerings. All applications and products are juried so that we may maintain this balance. Our goal is to keep high and promote a safe, successful and fun festival. The policies and regulations set forth in this document are designed to maintain order and to regulate activities on the Festival site. Regulations will be enforced.

## **PROCEDURES**

The following application and agreement must be fully completed, signed and returned with the following enclosures in order to be considered for participation:

1. Five (5) photographs: Four (4) of artwork/product and One (1) of your booth.
2. A detailed list of all proposed products/artwork to be sold. **Primary sale item must have garlic theme.**
3. A booth fee of \$200.00 for a 10'x10' booth *and* a separate non-refundable check of \$25 jury fee for first time vendors with a completed, signed application by July 1,2010.
4. Signed Affirmation and Liability Release form (attached to this application) *or* Certificate of Insurance naming **Ski Shawnee, Inc** and **Pocono Garlic Festival LLC** as an additional insured.

## Conditions for 2010

1. All locations will be assigned by SSI and PGF staff. While written requests will be considered, placement will be at the sole discretion of SSI and PGF staff. Use of Shawnee Mountain property is strictly limited to assigned location.
2. Exhibitor/Concessionaire parking is provided in designated areas only. With the exception of specified set-up/load-in and break down/load-out times, vehicles will not be permitted at the event site. Vehicles are to be removed immediately when asked to be by PGF or SSI staff.
3. A photograph of the crafters set-up and detailed description of all products/items to be sold is required with the application before the application can be approved. A jury appointed by PGF and SSI will determine the exhibitors at the Festival. Any product not juried will not be allowed at the Festival. Any product not juried will not be allowed at the Festival. Items will be removed from the concession stand asked by SSI or PGF staff during the festival if they were not approved. Failure to abide may result in not being asked back to the festival.
4. All crafters must have work that is original and designed and executed by the craftsperson that reflects originality and competent craftsmanship. This means absolutely no manufactured or kit items permitted. Vendors that sell products made by others and offered for resale will not be considered for this festival.
5. **Crafters must have garlic themed items at their booth.** Garlic themed products must be prominently displayed, not used as a side display!
6. Crafters are required to keep a neat, presentable booth at all times. Tables should be covered to the ground. Empty boxes and trash will not be permitted around the booth. All signs and displays must be of a professionally produced nature. One artist per space. Crafters must provide their own booth, tables, chairs and tents.
7. It is the sole responsibility of each exhibitor/crafter to obtain the applicable and appropriate state and local licenses and permits as well as payment of taxes pertaining to their operation.
8. A limited number of electrical hook-ups will be available (see application). Electrical arrangements must be made prior to your arrival. You may use propane to run your booth during the day. Generators may only be used with SSI and PGF approval. Vendor agrees to hold **Ski Shawnee, Inc and Pocono Garlic Festival, LLC** and any officers and/or owners of the aforementioned companies harmless for any damage to equipment caused by any malfunction.
9. SSI and PGF will provide day and evening security, but, exhibitor agrees to hold above listed organization harmless for any injury, theft, or other loss that may occur to property or person during the load-in/set-up, event, and break-down/load-out of the festival.
10. SSI and PGF reserves the right to restrict which items will be sold, to include exclusive agreements with national product lines and those who have entered an agreement with SSI and PGF to be the "official" vendor such as; beer, wine and Festival T-shirts.
11. **Craft Exhibitors are not to begin striking their display until Sunday at 6:00pm.** Booths must remain open until the event closes, *even if exhibitor is sold out*. Leaving early makes the festival look in disarray and vendors who leave early will not be allowed to participate in the festival again.

**Insurance Reminder!!** All Vendors are required to submit a Affirmation and Liability Release form or proof of general liability insurance. This must be mailed with your application no later that July 1<sup>st</sup>, 2010 otherwise your vendor space will be released to a vendor on the waiting list.
